UPON THE TERMS AND SUBJECT TO THE CONDITIONS, as follows:

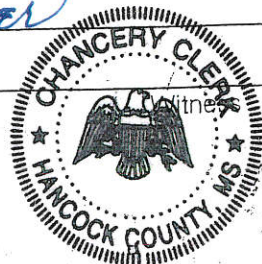
1. The structure or part thereof to which these conditions apply is:
